



EUROPE COUNTIRES GENERAL REQUIREMENTS

Tourist Visa / Family Visit Visa Requirement:

- Application form duly filled and signed by the applicant.
- 3 photographs(white background-non glossy paper 35mm x 45 mm)
- Original passport valid for at least 6 months and previous passports if any.
- Cnic copy
- If Family Visit: Invitation letter from sponsor and supporting documents.
- Family registration certificate / Marriage Certificate
- Original signed letter of the applicant's company/employer stating name, purpose of visit, position, salary, duration of employment, address and contact numbers of the employer, purpose and duration of visit to the Schengen state(s).
- Update Personal Bank Statement + Account maintain Certificate letter from Bank
- National Tax Number Certificate for the previous two years and proof of income tax payment (FBR)
- Last three month salary slips
- Travel insurance following documents required beneficiary name/address/cell number/Passport copy
- Polio Certificate required of each applicant.
- Personal Appearance is must

Business Visa Requirement:

- Application form duly filled and signed by the applicant.
- 3 photographs(white background-non glossy paper 35mm x 45 mm)
- Original passport valid for at least 6 months and previous passports if any.
- Cnic copy
- Family registration certificate / Marriage Certificate
- Invitation letter from the company / supporting documents
- Original signed letter of the applicant's company/employer stating name, position, salary, duration of
 employment, address and contact numbers of the employer, purpose and duration of visit to the Schengen
 state(s).
- Update Personal Bank Statement + Company Bank Statement and Account maintain Certificate letter from Bank
- Company and personal National Tax Number Certificate for the previous two years and proof of income tax payment (FBR)
- Last three month salary slips if employed
- Travel insurance following documents required beneficiary name/address/cell number/Passport copy
- Polio Certificate required of each applicant.
- Personal Appearance is must

- Gerry's Service fee 9690/- PKR equivalent 30 Euro Fees is subject to change anytime (ROE Applies)
- Processing time: 20 days or subject to approval

Netherlands:

- Visa Fees: 80 Euro (<u>Fees is subject to change anytime (ROE Applies)</u>
